STATUTORY HISTORY

West Virginia Code § 30-27, rewritten in July 2009 and edited in July 2011 to provide the Board authority to implement a barber apprenticeship program and shampoo assistant permit is accompanied by nine rules and regulations that govern or detail the practice, operations, businesses, schools, curricula, fees, and fines associated with beauty culture.

The rules and regulations that are currently in effect are:

3CSR1-Procedures, Criteria, and Curricula for Examination and Licensure of Barbers, Cosmetologists, Manicurists, and Aestheticians (last updated July 1st, 2011)

3CSR2- Qualification, Training, and Examination of Licensure of Instructors (last updated July 1st, 2011)

3CSR3- Rules and Regulations for Licensing Schools

3CSR4-Operational Standards for Schools of Barbering and Beauty Culture (last updated July 1st, 2011)

3CSR5-Operation of Baber, Beauty Shops, and Schools

3CSR6- Schedule of Fees (last updated July 1st, 2011)

3CSR7- Schedule of Fines

3CSR9- Complaint Procedures

3CSR11- Continuing Education

NEW LEGISLATION

During the 2012 legislative session, the Board hopes to accomplish two key pieces of legislation to help make the professions under this Board more accessible by lowering the required hours to national standards and to implement a job creating rule that will allow salons to hire shampoo assistants with 3 hours of sanitation training.



MISSION STATEMENT

The mission of the West Virginia State Board of Barbers and Cosmetologists is to ensure the public's protection while seeking professional services in the beauty industry through frequent sanitary inspections of salons/shops/schools, sanitary and disinfection inspections of implements used on consumers, and through competency examination of all licensed professional aestheticians, barbers, cosmetologists, and nail technicians.

OPERATIONS

- Issues licenses to qualified applicants.
- Processes applications and documents for licenses and permits.
- Maintains database of all licensees, shops, salons, and schools.
- Maintains record of all proceedings of the board.
- Inspects licensed shops, salons, and schools within the jurisdiction of the board.
- Investigates and processes complaints against barbers, cosmetologists, manicurists, aestheticians, salons, shops, and schools.
- Establishes procedures and guidelines for the suspension or revocation of a license and suspends, revokes, and reinstates those licenses.
- Conducts hearings on licensing issues and any other matter within the jurisdiction of the board.
- Responds to requests for information relating to licensees, functions of the board, or upcoming events.
- Responds to requests related to verification of licensees and certification, discipline cases, complaints, and the functions of the board.
- Implements rules and regulations relative to the practice of beauty culture.
- Reviews and evaluates multistate regulations.
- Establishes, implements, and regulates the curriculum in all licensed schools by legislative rule.
- Establishes and regulates licensing standards for individuals, shops, salons, and schools by legislative rule.
- Oversee examination for applicants to become licensed barbers, cosmetologists, manicurist, or aestheticians.
- Prepares and supervises annual budget and reports.
- Provides support services for inspectors.
- Provides collection and accounting for license, permit, examination, and other applicable fees.

FISCAL YEAR 2011 BOARD GOALS AND OBJECTIVES

This section covers the planned goals and objectives as indicated in the 2010 Annual Report. The red font explains the results of the planned goals and objectives.

- Research scan bar technology and photographs of licensees to be placed on licenses.
 2012 individual licenses will have barcode technology on license. The capabilities of having photographs on licenses are still being developed.
- Implement online license renewals.
 Shop licenses, individual licenses, and booth rental certifications are renewable online.
- Improve customer service and turn-around time for renewals.
 Licenses that are renewed online are processed and mailed within 1-3 business days.
 Licenses renewed by check or money order usually take 4-7 business days to be processed and mailed.
- Research biennial renewals for facilities and/or individuals.
 The idea of biennial renewals is on hold for individuals until continuing education, which starts January 1st, 2012, has been implemented.
- 5. Develop and implement "grading" system for inspection report results of salons/shops.

 New inspection process was created and implemented during fiscal year 2011. The inspection report focuses on sanitary factors that may be harmful to the public.

FISCAL YEAR 2012 BOARD GOALS AND OBJECTIVES

- 1. Digitally scan individual licensee files back to 2008.
- 2. Digitally scan past miscellaneous records and historic files.
- 3. Create public access to salon/shop/school inspection reports online.
- 4. Resolve 90% of complaints within nine months.
- 5. Inspection 90% of licensed facilities twice per year.
- 6. Improve average turnaround time for all applications to 5 days, except for application that require research.

BOARD'S NATIONAL PRESENCE

The West Virginia State Board of Barbers and Cosmetologists became the first state in the nation to implement and execute electronic license certifications or e-certifications. A license certification is a document that is required when an individual wishes to transfer a license from one state to another to validate the individual's license.

In the past, the Board would send a letter through the US Post Office certifying an individual's basic information such as: name, address, license number, and current license status. This process was slow, costly, and ineffective for validating an individual's training and identity.

Under the new process, the Board scans the individual's complete file and emails the scanned file (includes photograph, beauty school transcripts, and other specific information) with the e-certification directly to the state the individual is wishing to move. This process ensures that credentials are comparable to the receiving state and that the identity of the individual is correct. All social security numbers, birth months, and birth days are redacted.

Since the implementation in January 2011, the Board has received warm reception of the concept from several states. Three states have followed West Virginia's lead and a couple of additional states are in the process of implementing e-certifications in the near future.







DISTRIBUTION OF ALL LICENSES






Graph- Aesthetician



Graph- Barber/Barber Perm




Graph-Barber/Cosmo




Graph-Cosmetologists



Graph-Instructors




Graph- Nail Technicians



Graph- Schools







Graph- Out-of-State License Holder by License






Graph-Aestheticians



Graph- Barbers




Graph-Cosmetologists



Graph- Nail Technicians




Graph- Shops




