Dear Mr. Higginbotham,

In our attempt to purchase Valley Beauty Schools we, the BluHare Group, found some alarming practices that were taking place within the institution. I am inquiring about the status of Valley Beauty Schools.

The BluHare Group; Mark Binegar, Chad Clark, William Reeder and Donna Hall, sued Robert Bhavnani in the Washington County Court of Common Pleas. On September 29 and 30, 2008, the Honorable Judge Susan Boyer presided over the case. We sued to get our \$100,000 back as a down-payment on Valley Beauty Schools. While in negotiation to purchase Valley Beauty Schools we learned of various unethical and what we believed to be illegal practices taking place within that business. We won our case and Mr. Bhavnani was found guilty on charges of egregious fraud and breach of contract.

During the time that we discovered certain business practices, which were reported to; The Ohio State Board of Cosmetology, The WV Board of Barbers and Cosmetologists, The Department Of Education, the Internal Revenue Service and NACCAS, we were concerned that if we followed through with the transaction we would be held liable and face certain penalty and prison time. As we were told by the Department Of Education the person or persons holding ownership would be held accountable if there was ever an investigation, not the former owner, Robert Bhavnani.

Numerous witnesses were never subpoenaed or deposed. However the ones that were subpoenaed, their testimonies were more than enough to find Mr. Bhavnani guilty.

Enclosed are key statements from our trial. Please read the enclosed court transcripts and just maybe there will be somebody that actually cares about the injustice that this man has done to us. We would like to know why Mr. Bhavnani is still allowed to practice in the cosmetology field?

This has, for the time being, left us unable to accomplish our dream of having a cosmetology school. As a stylist of 26 years and business owner for 24 years I can attest that we are in dire need of an institution that can teach professionals.
